## ORANGE COUNTY RESOLUTION NO. 97-M-56

A RESOLUTION PERTAINING TO THE INTERNATIONAL DRIVE BUS SERVICE MUNICIPAL SERVICE TAXING UNIT; AMENDING ORANGE COUNTY RESOLUTION NO. 92-M-65 TO EXTEND THE DATE FOR ABOLITION OF THE MUNICIPAL SERVICE TAXING UNIT TO OCTOBER 1, 2000; AMENDING SECTION 8 OF ORANGE COUNTY RESOLUTION NO. 92-M-65 TO EXTEND THE DATE FOR REPEAL OF THE RESOLUTION TO OCTOBER 1, 2000; PROVIDING FOR SEVERABILITY; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Board of County Commissioners adopted Resolution No. 92-M-65 which created the International Drive Bus Service Municipal Service Taxing Unit (the "Taxing Unit"); and

WHEREAS, pursuant to Resolution No. 92-M-65, the Board of County Commissioners is authorized to levy ad valorem taxes upon taxable real and personal property within the Taxing Unit at rates not in excess of 1.0 mill per annum; and

WHEREAS, Section 6 of Resolution No. 92-M-65 provided for the abolition of the Taxing Unit on October 1, 1998; and

WHEREAS, Section 8 of Resolution No. 92-M-65 provided for the Resolution to be repealed on October 1, 1998; and

WHEREAS, the Board of County Commissioners and the Governing Board of the International Drive Master Transit and Improvement District desire to extend the dates for abolishment of the Taxing Unit and for repeal of the Resolution to October 1, 2000.

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF ORANGE COUNTY, FLORIDA:

<u>Section 1</u>. Section 6 of Resolution No. 92-M-65 is hereby amended to read as follows:

"Section 6. Abolition of Taxing Unit. The Taxing Unit

is abolished on October 1, 1998 October 1, 2000."

<u>Section 2</u>. Section 8 of Resolution No. 92-M-65 is hereby amended to read as follows:

"Section 8. Sunset Provision. This Resolution is hereby repealed on October 1, 1998 October 1, 2000."

Section 3. Severability. If any provision of this Resolution or the application thereof to any person or circumstance is held invalid, the invalidity shall not affect other provisions or applications of this Resolution which can be given effect without the valid provision or application and to this end the provisions of this Resolution are declared severable.

Section 4. <u>Effective Date</u>. This Resolution shall take effect upon enactment by the City Council of the City of Orlando of an ordinance consenting to the extension dates as provided in this Resolution.
