ORANGE COUNTY ORDINANCE NO. 96-30

AN ORDINANCE PERTAINING TO INTERNATIONAL DRIVE MASTER TRANSIT AND IMPROVEMENT DISTRICT; AMENDING SECTION 3.02 OF ORDINANCE NO. 92-37, AS CODIFIED IN SECTION 33-254 OF THE ORANGE COUNTY CODE, TO EXTEND THE SUNSET PROVISION FOR THE DISTRICT TO OCTOBER 1, 2000; AMENDING SECTION 3.04 OF ORDINANCE NO. 92-37 TO EXTEND THE SUNSET DATE OF THE ORDINANCE; PROVIDING FOR SEVERABILITY; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Board of County Commissioners of Orange County, Florida, adopted Ordinance No. 92-37 on November 10, 1992, which created the International Drive Master Transit and Improvement District (the "District"); and

WHEREAS, Section 3.02 of the Ordinance, which is codified in Section 33-254 of the Orange County Code, provides that the District will be automatically abolished on October 1, 1998; and

WHEREAS, Section 3.04 of the Ordinance provides that the Ordinance is repealed on October 1, 1998; and

WHEREAS, the Governing Board of the District desires to have the sunset provisions for the District and the Ordinance extended to October 1, 2000; and

WHEREAS, the Board of County Commissioners of Orange County, Florida desires to extend the sunset provisions as well.

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF ORANGE COUNTY, FLORIDA:

Section 1. Section 3.02 of Ordinance No. 92-37, as codified in Section 33-254 of the Orange County Code, is hereby amended to read as follows:

SECTION 33-254. ABOLITION OF DISTRICT. The District is abolished on October 1, ~~1998~~ 2000. Notwithstanding any other provision of this Ordinance to the contrary, the Governing Board shall not be empowered to incur any obligation or enter into any agreement requiring performance after September 30, ~~1998~~ 2000.

Section 2. Section 3.04 of Ordinance No. 92-37 is hereby amended to read as follows:

SECTION 3.04. SUNSET PROVISION. This Ordinance is hereby repealed on October 1, ~~1998~~ 2000.

Section 3. Severability. If any provision of this Ordinance or the application thereof to any person or circumstance is held invalid, the invalidity shall not affect other provisions or applications of this Ordinance which can be given effect without the valid provision or application and to this end the provisions of this Ordinance are declared severable.

Section 4. Effective Date. This Ordinance shall take effect pursuant to general law.
