AN ORDINANCE PERTAINING TO FINANCE; AMENDING SECTIONS 33-271 AND 33-277 OF THE ORANGE COUNTY CODE TO REVISE THE DESCRIPTION OF THE PROPERTIES INCLUDED IN THE INTERNATIONAL DRIVE MASTER TRANSIT AND IMPROVEMENT DISTRICT, THE BUS SERVICE AREA AND THE NORTH INTERNATIONAL DRIVE IMPROVEMENT AREA; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Board of County Commissioners of Orange County, Florida (the "Board") on November 10, 1992, enacted Ordinance No. 92-37, which created the International Drive Master Transit and Improvement District (the "District") as an independent special district for the purpose of planning, designing, acquiring, constructing, operating and maintaining public transit systems, facilities and services within the District; and

WHEREAS, Ordinance No. 92-37 also created the Bus Service Area and the North International Drive Improvement Area; and

WHEREAS, Appendices A, B and C to Ordinance No. 92-37 contain the description by parcel number of the properties located within the District, the Bus Service Area, and the North International Drive Improvement Area respectively; and

WHEREAS, on December 22, 1992, the Board enacted Ordinance No. 92-40 which revised the description of the properties included in the District, Bus Service Area, and the North International Drive Improvement Area which were described in Appendices A, B and C respectively to Ordinance No. 92-37; and

WHEREAS, on November 7, 1995, the Board enacted Ordinance No. 95-34 which revised the description of the properties included in the District and the Bus Service Area to add additional parcels of land; and

WHEREAS, Ordinance No. 92-37, Ordinance No. 92-40 and Ordinance No. 95-34 (collectively, the "Enabling Ordinance") are codified in the Orange County Code in Sections 33-251 through Sections 33-279, inclusive; and

WHEREAS, the Board desires to revise Appendices A, B and C of the Enabling Ordinance by adding additional parcels to the District and the Bus Service Area and deleting certain parcels from the District, the Bus Service Area and the North International Drive Improvement Area.

ACCORDINGLY, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF ORANGE COUNTY, FLORIDA

Section 1. Appendix A of the Enabling Ordinance, as codified in Section 33-271 of the Orange County Code, is hereby amended to add the parcel listings set forth in Exhibit A and to delete the parcel listing set forth in Exhibit C, both of which are attached to this Ordinance and incorporated herein by reference. Said Appendix A of the Enabling Ordinance is hereby replaced with the revised Appendix

A appended hereto, and incorporated herein by this reference. Said revised Appendix A appended hereto shall be construed as supplanting and replacing the Appendix A appended to the Enabling Ordinance.

Section 2. Appendix B of the Enabling Ordinance, as codified in Section 33-277 of the Orange County Code, is hereby amended to add the parcel listings set forth in Exhibit B and to delete the parcel listing set forth in Exhibit D, both of which are attached to this Ordinance and incorporated herein by reference. Said Appendix B of the Enabling Ordinance is hereby replaced with the revised Appendix B appended hereto, and incorporated herein by this reference. Said revised Appendix B appended hereto shall be construed as supplanting and replacing the Appendix B appended to the Enabling Ordinance.

Section 3. Appendix C of the Enabling Ordinance, as codified in Section 33-278 of the Orange County Code, is hereby amended to delete the parcel listings set forth in Exhibit E, which is attached to this Ordinance and incorporated herein by reference. Said Appendix C of the Enabling Ordinance is hereby replaced with the revised Appendix C appended hereto, and incorporated herein by this reference. Said revised Appendix C appended hereto shall be construed as supplanting and replacing the Appendix C appended to the Enabling Ordinance.

Section 4. Exhibits A, B, C, D and E attached hereto and Appendices A, B and C appended hereto shall be construed as amending and replacing Appendices A, B and C to the Enabling Ordinance to add additional parcels to the District and Bus Service Area and to delete certain parcels from the District, the Bus Service Area and the North International Drive Improvement Area. Except for this purpose of adding certain additional parcels and deleting certain parcels, the Enabling Ordinance shall remain unchanged and in full force and effect.

Section 5. Severability. If any provision of this Ordinance or the application thereof to any person or circumstance is held invalid, the invalidity shall not affect other provisions or applications of this Ordinance which can be given effect without the invalid provision or application and to this end the provisions of this Ordinance are declared severable.

Section 6. Effective Date. This Ordinance shall become effective as provided by general law.

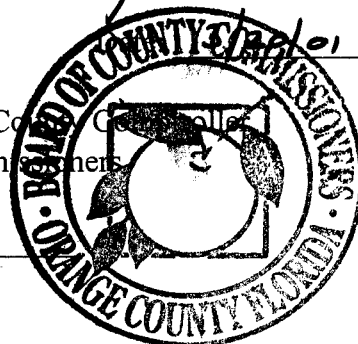
